**TERMS AND CONDITIONS:**

1. Fees for handling are as follows: \$2 per day for board, \$50 per show, and \$.05 per mile to/from the shows. These fees are subject to change with written notice and an addendum to this contract will be signed at that time. Billing is done on a pre-pay basis. A \$500 deposit to be applied towards entries and fees is due at signing of this contract. When balance reaches \$50 another \$500 is due.
2. **The following photocopied documentation must be supplied with the dog when TNT takes possession:** Rabies Certificate, AKC Registration, 5 generation pedigree. We prefer dogs standing at stud to also have: OFA Certificate, vWD VetGen results certificate, Eye exam/CERF #, and recent Thyroid results. If available, a recent show -type photo should also be provided for the TNT website for advertising purposes.
3. Board includes food, grooming, and conditioning of the dog for optimum appearance and performance in the AKC Conformation ring.
4. This contract signifies that the **dog owner commits to at least 10 shows**. If dog is pulled by the owner before the agreed upon 10 shows has been completed, the dog owner will pay a \$200 conditioning fee and will pay any outstanding balance before dog is surrendered back to their care.
5. All dogs will be shown by us, except when circumstances arise beyond our control, in which case one of our assistants or another competent handler of our choice will handle the dogs. Regular fees will apply.
6. Owner/client is responsible for paying handling fees unless the owner/client withdraws the entry and we are notified prior to the show closing date.
7. Class to be entered in will be determined according to the dog's seniority in TNT's current handling lineup. The most senior dog/client will have priority in the Open classes. Less senior dogs will be entered in the appropriate American Bred, Junior or Puppy classes.
8. If the dog is entered and not shown due to the inconvenience or any personal reason of the owner, the owner will be billed for the normal handling amount.
9. All telephone calls from shows will be at the expense of the owner(s).
10. The dog is required to be healthy and clean and up to date on all vaccinations (DA<sub>2</sub>PP, Bordetella, & Rabies). The dog must be parasite free and on heartworm preventative. If this dog contaminates the housing facility with either internal or external parasites, there will be an extra charge for the correction of this problem. If other dogs in the facility are contaminated with parasites, the owner of the contaminating dog will pay for vet charges for treatment of the contaminated dogs. The dog owner will pay for any treatment of parasites, vaccinations, or vet visits. Any injuries due to fighting will be treated as needed and costs associated with that injury will be the responsibility of the dog owner.
11. Any pre-existing health conditions, past injuries, or temperament issues (dog-aggressive, coat chewing, sound sensitivity, etc..) **MUST** be disclosed before TNT takes possession. If any undisclosed conditions, injuries or issues are discovered after TNT has taken possession of the dog, a \$100 penalty will be charged and depending on the severity of the issue, the dog may be returned at the owner's expense, unless other arrangements are made and an addendum & waiver is signed and added to this contract.
12. Dogs standing at stud while being handled by TNT Presentation will be bred by artificial insemination unless a clear vaginal culture and negative Brucellosis test is provided before breeding. Stud fees will be applied towards the dog's balance, minus a \$100 handling fee for the mating. All records of the mating and a copy of the stud contract will be provided to the stud owner.
13. TNT Presentation will not be responsible for any unfortunate accidents that occur while the dog is in their possession, unless negligence can be proven.
